The date of meeting of the Board of Directors to approve the Un-audited Financial Results of the Company for the quarter ended on 31st December, 2023 will be informed in due course.

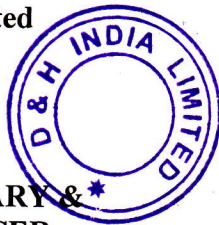

Subject: Notice for Closure of Trading Window

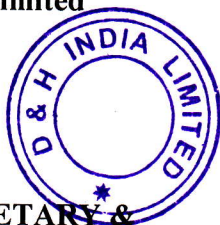
